3. Partnership will only be confirmed on receipt of the completed and signed partnership contract as well as a PO No/ early receipt of payment
4. The law of South Africa governs this contract
5. Logos to be provided in jpeg format and emailed to [chipo@eventsmanagement.co.za](mailto:chipo@eventsmanagement.co.za) within 24 hours of commitment to ensure that the organisers are able to offer maximum exposure
6. All exhibitors are to comply with the Exhibition Rules and Regulations as determined by the venue, as well as the Occupational Health & Safety Act
7. Any deposits paid to the Organiser are non-refundable
8. Any cancellations received from the Partner 45 days prior to the start of the conference will attract a 100% cancellation fee of the total value of Partnership.
